

**VOLUNTEER AGREEMENT WAIVER AND RELEASE OF LIABILITY FORM**

The above-named Volunteer agrees to help in the 2017 Simplot Games (hereinafter “Track Meet”). I, the undersigned, understand that participation in the Track Meet involves a potential risk of injury. I acknowledge and assume all risks associated with participating in this Track Meet as a volunteer, including, but not limited to: falls; contact with other volunteers, participants or officials; the condition of the premises and/or of the equipment used; and extremes of temperature or humidity. There may be OTHER RISKS inherent in the Track Meet, whether foreseeable or not known or not reasonably foreseeable. Understanding all of the above, the undersigned, individually and as the parent or guardian of the Volunteer, hereby expressly assumes all risks associated with the Volunteer’s participation in the Track Meet including all risks associated with track and field including the equipment involved, and including travel en route to and from the Track Meet.

Despite my understanding of the foregoing risks, the undersigned, individually and as the parent or legal guardian of the Volunteer, agrees to not sue and to release from liability and to defend, indemnify and hold harmless the Simplot Games and USA Track and Field, their respective Board of Directors, representatives, employees, volunteers, officials, sponsors, advertisers, agents, and any other persons affiliated with the Track Meet for any damage or injury arising out of the Volunteer’s participation in the Track Meet regardless of cause, even though that liability may arise out of negligence or fault on the part of the persons identified in this waiver. I intend and agree that this release is as broad and inclusive as permitted by applicable law, and if any portion thereof is invalid, I intend and agree that the balance shall continue in full legal force and effect.

I understand that the foregoing is legally binding in consideration of my participation in the Track Meet as a Volunteer, and I sign this Agreement of my own free will. In the event of injury, I hereby consent to emergency medical treatment. Additionally, I acknowledge that media will be present, and that by participating in the Track Meet, the Volunteer’s photograph, likeness and/or voice may appear in documentary, promotional (including any and all advertisements), television, radio or film coverage of the Track Meet, without compensation.
